## Best of Breed Competition

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

#### Select

When quality warrants, after BOB and BOS to BOB are awarded, a Select Dog (SD) and Select Bitch (SB) may be chosen form the remaining Champions (Non Regular Class winners that are Champions and Qualify for BOB are eligible) - (WD or WB are not eligible) ( AKC Dog Shows Rules, Chapter 3, Section 14 Effective 5-12-10)

#### Awards of Merit

The BCSFV is offering awards of merit to enable judges at their discretion to recognize and Acknowledge deserving exhibits in BOB competition who have not been awarded BOB or BOS.

The awards will be green and gold rosettes.

The awards will be offered based on the following number of champions entered in Best of Breed competition:

4 to 6 champions = One Award of Merit 7 to 11 Champions = Two Awards of Merit

## 12 to 16 Champions = Three Awards of Merit Bred By Exhibitor Eligibility

All dogs entered in the Bred-By Class must be individually registered with the AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. Family members must be both a breeder and owner of record to exhibit in the class. Any entry in Bred-by-Exhibitor classes that is awarded Best of Breed or Best of Winners would automatically be Best Bred-by-Exhibitor.

#### Best Puppy

After Best of Breed judging the winner of each Puppy Class will compete for best puppy. Any entry in the puppy classes that is awarded Best of Breed or Best of Winners would automatically be Best Puppy. Only dogs not defeated in a puppy class are eligible for Best Puppy competition.

## Non-Regular Classes Involving Single Dog Entries

Veteran Dogs, 6 years and over

Veteran Bitches, 6 years and over

Neutered Dogs and Spayed Bitches may compete in the Veterans Classes only at independent specialties and by virtue of winning the class may compete for Best of Breed. (AKC Dog Show Rules, Chapter 14, Section 8.)

## Non-Regular Classes Involving Multiple Dog Entries

Stud Dog Class - Will be for Stud Dogs and a maximum of two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of the Get. Get only to be judged, based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry the Stud Dog must be examined to determine

if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for the breed. Get must be entered in a Regular Class. Best of Breed Competition or some other Non-Regular Class.

Brood Bitch Class - The same as Stud Dog except substitute Brood Bitch for Stud Dog & Produce for Get. As the judge's decision in the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed Competition by virtue of having won these classes.

## SWEEPSTAKES

Classes: Each age group is divided by sex, not by color

Puppy: 6 months - under 9 months: 9 months - under 12 months Junior: 12 months under 18 months

#### CONDITIONS

Sweepstakes will be judged before the Veteran Sweepstakes. Entries are open to non-members as well as members. Entries in the Sweepstakes must also be entered in a regular class and entries must be made at the same time as regular entries and must be on the same entry blank under "Additional Classes."

Champions of Record are NOT eligible to compete.

## Two (2) Stakes will be created for the Sweepstakes:

1. One exclusively for Puppy Competition 2. One exclusively for Junior Competition Sweepstakes entry fees received for Puppy Classes will become part of the Stake for Puppy Competition ONLY after deduction of 30% for sweepstakes expenses. The above applies to Junior Competition as well, with total monies received from donations to be divided equally between Puppy and Junior Sweepstakes Classes. In the event there are no entries in the designated classes, the percentage shares of stake for that class shall be divided equally among the other classes.

The Puppy Competition Classes and Cash Stakes will be divided as follow:

OWNER of BEST PUPPY (6 to 9 months) DOG & BITCH - 20% each OWNER of BEST PUPPY (9 to 12 months) DOG & BITCH - 20% each

OWNER of BEST PUPPY in PUPPY CLASSES - 20% each

The Junior Competition Classes and Cash Stakes will be divided as follow:

OWNER of BEST JUNIOR (12 to 18 months) DOG & BITCH – 33% each OWNER of BEST IN JUNIOR CLASSES - 33% each

BEST IN PUPPY SWEEPSTAKES WINNER will compete against the BEST IN JUNIOR SWEEPSTAKES for GRAND SWEEPSTAKES WINNER

## VETERAN SWEEPSTAKES

Classes: Each age group is divided by sex:

6 years - under 8 years; 8 years - under 10 years; Over 10 years

#### CONDITIONS

Veteran Sweepstakes will be judged after the Regular Sweepstakes and before the Specialty. Entries are open to non-members as well as members.

Entries in the Veteran Sweepstakes need not be entered in a regular class; however, entries must be made at the same time as regular entries and must be on the same entry blank under "Additional Classes."

Champions of Record are eligible to compete. Neutered Dogs and Spayed Bitches are eligible to compete.

## Two Stakes will be created for the Veteran Sweepstakes:

- One exclusively for Junior Competition (6 to 10 years)
- One exclusively for Senior Competition (Over 10 years) 2

Sweepstakes entry fees received for Junior Classes will become part of the Stake for Junior Competition only after deduction of 30% for sweepstakes expenses. The above applies to Senior Competition as well, with total monies received from donations to be divided equally between Junior and Senior Sweepstakes Classes. In the event there are no entries in the designated classes, the percentage shares of stake for that class shall be divided equally among the other classes.

#### The Junior Competition Classes and Cash Stakes will be divided as follow:

OWNER of BEST JUNIOR (6 to 8 years) DOG & BITCH - 20% each OWNER of BEST JUNIOR (8 to 10 years) DOG & BITCH - 20% each

OWNER of the BEST in JUNIOR VETERAN CLASSES - 20%

The Senior Competition Classes and Cash Stakes will be divided as follow:

OWNER of BEST SENIOR (Over 10 years) DOG & BITCH - 33% each

OWNER of BEST in SENIOR VETERAN CLASSES - 33%

BEST in JUNIOR VETERAN SWEEPSTAKES WINNER will compete against the BEST in SENIOR VETERAN SWEEPSTAKES WINNER for **GRAND VETERAN SWEEPSTAKES WINNER** 

## **Obedience Trial Classifications**

Beginners Novice A & B Novice A & B Open A & B Utility A & B

Optional Titling Classes: Grad Novice, Grad Open, Veterans and Brace

Beginner Novice Class. Any dog/handler that has never titled in AKC Obedience may enter the Beginner Novice "A" Class. If a dog/handler has ever earned an AKC Obedience title (ie., CD, CDX, UD) they must compete in the Beginner Novice "B" class. Handlers and dogs that have earned a Beginner Novice title from the "A" class and have no other AKC obedience titles are still eligible for the Regular Novice "A" class in obedience.

Graduate Novice: The Graduate Novice class shall be for CD dogs that have not been certified by a judge to have received a Qualifying Score toward a CDX title prior to the closing of entries. Dogs in

this class may be handled by owner or any other person. A person may handle more that one dog in this class, but each dog must have a separate handler for the Long Sit and Long Down exercises when judged in the same group. Dogs entered in Graduate Novice may also be entered in one of the Open Classes.

**Graduate Open:** The Graduate Open class will be for all dogs and is an optional titling class that may be offered by clubs at obedience events. The owner and any other person may handle dogs in this class. If eligible as defined in these regulations, dogs entered in Graduate Open may also be entered in an other obedience class.

## Non Regular Classifications

Class shall be conducted in accord with AKC rules and regulations.

Veterans: The Veterans class shall be for dogs that have an obedience title and are seven or more years old on the date of the trial. The exercises shall be performed and judged as in the Novice class. Dogs entered in the Veterans Class may be entered in any regular class.

Brace: The Brace class will be for two dogs of the same breed or two dogs listed with AKC Canine Partners of similar height at the withers that are eligible under the regulation and capable of performing the Novice exercise.

## Rally Trial Classifications

Novice A & B Advanced A & B Excellent A & B

Non Regular Classifications - class shall be conducted in accord with AKC rules and regulations

Pairs Novice Pairs Advanced Pairs Excellent
Team Novice Team Advanced Team Excellent

Rally Pairs Class. Rally Pairs class consists of competition by one handler working two dogs at one time through a rally course at a level selected and offered by the event-giving club. Scores will be based on a possible 200 points, with ties being broken by time.

Rally Team Class. For the non-regular Rally Team competition, any of the regular rally class levels may be offered The Rally Team Competition will be for teams of any four dogs that are eligible under these regulations.

Five dogs may be entered, one to be considered an alternate for which no entry fee will be required.

## Junior Showmanship Competition

**RULES EFFECTIVE NOVEMBER 8, 2011** 

AKC Junior Handler Numbers are assigned by AKC and required for entry in AKC Events.

The Junior Handler Number may be obtained by calling the American Kennel Club (919) 816-3776 NOVICE - This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the times of entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**JUNIOR** - This class shall be for boys or girls who are at least 9 years old and under 12 years old on the day of the show.

INTERMEDIATE - This class shall be for boys or girls who are at least 12 years old and under 15 years old on day of the show.

SENIOR - This class shall be for boys or girls who are at least 15 years old and under 18 years old on the day of show.

<u>OPEN</u> - This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, who have won 3 first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class a the same show provided the win is the (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

**JUNIOR** - This class shall be for boys or girls who are at least 9 years old and under 12 years old on the day of the show.

**INTERMEDIATE** -This class shall be for boys or girls who are at least 12 years old and under 15 years old on day of the show.

SENIOR - This class shall be for boys or girls who are at least 15 years old and under 18 years old on the day of show.

MASTER- This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**BEST JUNIOR HANDLER:** A club offering Junior Showmanship may offer a prize for Best Junior Handler. The prize must be described in the Premium List. The Junior Handler place first in each or the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete for this prize.

**JUNIOR HANDLERS** who win a third Novice Class after the Closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Show Secretary at least one-half hour prior to the scheduled start of the earliest conformation judging or one-half hour prior to the scheduled start of Junior Showmanship judging at the Show, whichever is earlier.

**PLEASE NOTE:** Juniors must include their AKC Junior Handler number on the entry blank. Be sure all information for Junior Showmanship Classes is entered on the <u>front and back</u> of the entry form. Dogs shown in Junior Showmanship may have Full or Limited AKC registration or have an ILP/PAL number. Altered animals are eligible to be shown, but bitches in season are not eligible.

There is no refund of entries fees for duplicate entry or overpayment of entry fees. If because of riots, civil disturbances, fire extreme and/or dangerous weather conditions, and Act of God, public emergency, act of a public enemy, strikes or another acts beyond the control of the Club or Show Secretary it is impossible to open or complete the show, no refund of entry fee will be made.

AN ADMINISTRATIVE FEE of \$2.00 will be charged for all cancellations or changes made prior to closing of entries.

ONLY DOGS THAT ARE ELIGIBLE to be shown under the American Kennel Club rules shall be allowed on the show grounds and dogs excused form further judging are to be removed promptly.

ALL DOGS SHALL BE held on leash or confined to their crates, except when being judged or when being exercised.

THERE SHALL BE NO drilling nor intensive or corrective training of dogs on the show grounds or premises.

DOGS MUST BE READY FOR JUDGING. The Club and its Show Secretary will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

DOGS NEED TO BE AT THE SHOW only at scheduled time for judging and may leave immediately thereafter, unless require for further judging.

THE CLUB reserves the right to substitute a prize of equal or greater value,

ALL TROPHIES must be claimed the day of the show. None will be mailed or otherwise distributed.

CLASS CASH PRIZES will be paid in the ring to the persons showing the dog. Claims for prize money must be made in the ring before the judging of that Breed is over and the Show Secretary's Office is advised at once. The Show Secretary and Show giving Club disclaim any liability for cash prizes after the judging of the Breed is over.

THE WELFARE OF AN EXHIBITOR'S CHILD is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the show. For everyone's safety, no baby strollers or wheeled child carriers are allowed on the show grounds.

ALL PERSONS ATTENDING THIS DOG SHOW hereby waive any claim for damages against Boxer Club of San Fernando Valley ventilation.
