Veteran Dog Class For dogs and bitches six (6) years of age or older. At independent Specialties, Neutered dogs and Spayed bitches may compete. The winners of these classes will compete for Best of Breed

#### **BEST OF BREED COMPETITION**

"The following categories of dogs may be entered and shown in Best of Breed competition. Dogs, which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If at the end of the 90-day period, the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC."

#### **BEST PUPPY**

After Best of Breed judging the winner of each Puppy Class will compete for Best Puppy. Any entry in the puppy classes that is awarded Best of Breed or Best of Winners would automatically be Best Puppy. Only dogs not defeated in a puppy class are eligible for Best Puppy competition.

#### **BEST BRED BY EXHIBITOR**

The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. Family members must be both a breeder and owner of record to exhibit in the class. Any entry in Bred-by-Exhibitor classes that is awarded Best of Breed or Best of Winners would automatically be Best Bred-by-Exhibitor.

#### AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned, co-owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form.

Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be** handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show. Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog.

#### **Competition Regulations**

Classifications - The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3. Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Fourto-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Entry and Eligibility - Entry and eligibility requirements include: The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club. • Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered. AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows. A foreign-born dog may enter this class if they are registered in the country of origin. FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.

All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol. Professional handlers are not permitted to exhibit in this class. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

Titles - The Certificate of Merit (CM) title is an introductory title to AKC conformation events. Entrants in each breed shall compete for Best of Breed and Best of Opposite Sex to Best of Breed. Winners of the Best of Breed in each of the individual breeds or varieties will be awarded points toward the CM title based on the number of dogs defeated in their breed or variety. Winners of Best of Opposite Sex to Best of Breed in each of the individual breeds or varieties will be awarded points toward the CM title based on the number of dogs defeated in their sex. Group winners will be eligible for the highest number of points earned by any breed within that Group. Best Four-to-Six Puppy in Show will be eligible for the highest number of points earned by any breed entered.

The Certificate of Merit requires 15 points awarded in accordance with the following points structure.

#### **Regular Classes**

**NOVICE** - This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the times of entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

**OPEN** - This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, who have won 3 first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

**MASTER-** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

**BEST JUNIOR HANDLER**: The Junior Handler placed first in each of the regular Junior Showmanship Classes, if undefeated in any other Junior Showmanship Class at that show, shall automatically be eligible to compete for this prize.

**To qualify for the Parade of Champions**, each Boxer must be a Champion or a Grand Champion.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels(King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. #### NOTICE TO EXHIBITORS

- Entries must reach the Show Secretary, Wag's Enterprises, 12520 Zehner Rd; Athens AL 35611 by Wednesday, December 13, 2023 by 6:00 PM. Fees must accompany entries. The Club and the Show Secretary assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. The Club and the Show Secretary assume no responsibility for the owner or owner's agent entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
- Returned checks do not constitute a valid entry fee. Show Secretary will add a \$35 collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.
- 3. Exhibitors' confirmations and judging programs will be mailed or emailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the Show Secretary. Confirmations returned by the Post Office marked "Undeliverable" will be held at the Show Secretary's office. Please bring your confirmations to the show.
- 4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly in order that judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owner of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, it's owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of these clubs nor the American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 8 AM to 6 PM.
- Trophies and prizes will be awarded in the judging ring by completion of the breed and the show secretaries office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
- Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany the premium list. Rule books may be obtained from the A.K.C., 5580 Centerview Dr., Suite 200, Raleigh, N.C. 27606.
- 7. The Club, the Show Secretary or the members or employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor/owner or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler/agent during the entire time the dog is on the show premises.
- No grooming tables, pens or exhibitors setups will be allowed in the aisles and all grooming must be done at least 20 ft. away from the judging ring in areas specified by the club.
- 9. Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Event Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fees for duplicate entry.
- 10. Only dogs that are eligible to compete to be allowed on the grounds.
- The Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Club or any official thereof.
- 12. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
- 13. Do not leave any dogs in closed vehicles.
- 14. A recording fee of .50 cents per dog and an event service fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show. These fees are to be collected by the Show Secretary and paid to the American Kennel Club. (American Kennel Club Rule, Chapter 11, Section 2.)
- 15. Dogs which according to their owners records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed Competition, provided this transfer is made by the Show Secretary at least one half hour prior to the start of the earliest Confirmation judging at the show.
- All persons attending this event hereby waive any claim for damages against the Club, or its, members, in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.
- 17. All vehicles parked in VIP Parking Area without VIP Pass will be ticketed and fined and possibly towed by instruction of the Venue staff
